

Asylum claims on the basis of sexual orientation

These data are experimental statistics and should be interpreted with caution. Experimental statistics are statistics that are in a testing phase and are not yet fully developed. These statistics have not been subject to the full level of quality assurance of National Statistics. Further details can be found in the Office for National Statistics Guide to Experimental Statistics.

The data show all main asylum claimants for whom the sexual orientation identifier has been completed on the Home Office system. This identifier should be completed by caseworkers where the basis of claim includes sexual orientation. This can be the sole basis of claim or one of multiple grounds, and can have been raised at any stage during the asylum case, appeal or other casework.

The data does not represent the number of asylum claimants who define themselves as LGB. Having an identifier that an asylum case is based on sexual orientation does not indicate that a claimant has any particular sexuality or that sexual orientation is the reason for any grant or refusal of asylum. It also does not signify whether that aspect of the claim has been accepted. Sexual orientation as a basis of claim could be due to imputed assertions or association rather than a defining characteristic of the claimant.

Data accuracy relies on caseworker completion of the sexual orientation identifier on the Home Office system. As a manual addition, the nature of the recording system used has potential for error from misapplication and omission, and inconsistent use over time. Although quality assurance has been carried out, and the Home Office has confidence that the majority of asylum cases with a sexual orientation basis have been recorded as such, some cases may still exist for which the sexual orientation identifier has been incorrectly applied.

Additional cases may be identified as undecided cases are considered, as claimants raise further grounds during the progression of their case, or as identifiers are added as a result of further quality assurance.

Only those countries with at least one unsuppressed value are included in the data tables. Data for those countries for which all values are suppressed, and which therefore do not appear in the 'Country of nationality' column, are totalled under 'Country of nationality - Other'.

Note that this does not include data for countries where some, but not all, values are suppressed. These data are included in the 'Total' row.

Criteria for suppression of data are given in the notes for each individual table, below.

Table SOC_01

Values of less than 5 have been suppressed, and replaced by *. These values are not included in the 'Other' row, but are included in the 'Total' row.

Table SOC_02

Values of less than 5 have been suppressed, and replaced by *. These values are not included in the 'Other' row, but are included in the 'Total' row.

Note that 'Total Grants' and 'Total Refusals' have been suppressed where either of these values is less than five in a given year.

Initial decisions are based on date of decision and do not necessarily relate to applications made in the same period. For example, a decision in 2017 may relate to an application made in 2016.

Initial decisions exclude the outcome of appeals or other subsequent decisions.

Figures for 'Total Decisions' include 'Total Grants' and 'Total Refusals', but do not include 'Total Withdrawals'.

Figures for 'Total Grants' include:

- Grants of asylum, Humanitarian Protection and Discretionary Leave
- Grants under family and private life rules, which relate to the introduction of a new approach to Article 8 of the European Convention on Human Rights
- Leave Outside the Rules, which was introduced for those refused asylum but where there were other exceptional and compassionate circumstances
- UASC leave, which was introduced for unaccompanied asylum-seeking children refused asylum but eligible for temporary leave until the age of 17.5

Table SOC_03

Values of less than 5 have been suppressed, and replaced by *. These values are not included in the 'Other' row, but are included in the 'Total' row.

Table SOC_04

Values of less than 5 have been suppressed, and replaced by *. These values are not included in the 'Other' row, but are included in the 'Total' row.

Note that 'Appeals Allowed' and 'Appeals Dismissed' have been suppressed where either of these values is less than five in a given year.

Appeal outcomes are based on date of determination and do not necessarily relate to appeals lodged in the same period. For example, a determination made in 2017 may relate to an appeal lodged in 2016.

Figures for 'Appeals Determined' include 'Appeals Allowed', 'Appeals Dismissed' and 'Appeals Withdrawn'.

HM Courts & Tribunals Service (HMCTS) (formerly the Tribunals Service Immigration and Asylum (TSIA)), consists of the First-tier Tribunal and Upper Tribunal of the Immigration and Asylum Chamber (FTTIAC and UTIAC). All figures for appeals determined are cases dealt with by Immigration Judges at the FTTIAC.

The appeals allowed figures may include a small number of cases where the asylum application was granted at initial decision, but later appealed against. This may be due to the circumstances of the grant (e.g. discretionary leave/UASC leave rather than asylum).

Withdrawn figures include cases withdrawn by the Home Office, as well as those withdrawn by the appellant.
